1. This ballot, properly marked, must be placed in envelope Number 1, marked "Ballot", and the same enclosed in the Business Reply Mail envelope and mailed to Attorney Lauren Landa, P.O. Box 1358, Elko, Nevada 89803 or delivered to the office of Attorney Lauren Landa, 530 Idaho Street, Elko, Nevada 89801. Ballots must be received on or before 5:00 P.M. on Wednesday, August 19, 2020. Late ballots will not be counted.

2. For the election to be valid, 417 ballots must be received.

3. Each member shall have the right to cast four (4) votes. However, a member is not required to cast all of the four (4) votes. Vote not more than four (4) votes. Ballots purporting to cast more than four (4) votes will not be counted. Please put one (1) X for each vote in the box next to (left of) the candidate's name.

4. The order in which the candidates were placed on the ballot was determined by lot.
